Discussion:

- Marilyn Buck reported on the cabinet meeting.
 - o President Gora wants more than one public forum for the accreditation.
- The committee discussed ideas for the forums.
 - o The committee thought three or four forums would be a good number.
 - o Different locations on campus.
 - o These are not limited to faculty.
 - o One in the evening would accommodate faculty and others working during the day.
 - There was a suggestion to go to faculty council, staff council, and student government (GSA) to ask for feedback on the accreditation report.

- o Suggestions for locations for the forums were:
 - Alumni Center
 - Park Hall
 - Kinghorn Hall
 - Library
 - Teachers College (TC-101)
 - Ball Communications (BC129)
- o The committee would like to webcast the forums.
- We should plan for 100 attending each forum.
- o An interactive phone line or email address so there could be a number count of how many logged in.
- o Accept comments online or in real time.
- o Forums should be scheduled between October 24 and Thanksgiving break.
 - Work with Laura Helms to determine what is available.
- o We need to work to get the word out to the Muncie Community.
 - Include the Alumni
 - CEO group in Indianapolis
- o Bill Knight will work on a link from the survey.
- Putting an ad in the Star Press to invite the community in the evening at the Student Center.
- o The committee thought that it was important to acknowledge the feedback we receive.
- o There was discussion about the need for a host for the forums.
- Ask five or six people to read sections and ask questions to get responses and interaction at the forums.
- o Having one of the forums off campus. At the Horizon Center or Muncie Central High School.
- o Greg Wright will organize the invitation to join the web stream.
- The committee wants the forums to address
 - What might have been missed
 - o What we got wrong
 - o Is there a better example
- Ted Buck talked about the issues he found in the drafts.
 - o He felt the drafts needed more references to the new Strategic Plan.
 - o More information from the new NSEE will be incorporated.
 - o Michael Maggiotto suggested Criterions 3 and 4 talk to Malcolm Cairns about rigor. The Provost created a task force on rigor and Malcolm is heading this up.
 - o Ted will concentrate on citations on the next review but he notice there is a varying degree of citations amongst the different criterions.
 - As a reminder, the committee is to write to the core components not the subcomponents.
 - O Ted liked that some of the committees addressed challenges and recommendations as a separate summary or section. He is not sure if he wants to pull data out of the text so they all have a section like this. Mike Maggiotto
