THEATRE DANCE ART

THEATRE/DANCE

Acting, musical theatre, and dance are the only options in the Department of Theatre and Dance that require a separate application and audition for admission as a freshman. Students interested in non-performance options—design and technology, production, theatrical studies, or theatre education—must apply and audition to the department only if they want to be considered for scholarships.

Please note that the department awards scholarships in all areas (performance, design, production, and education) and encourages all interested students who meet the minimum academic requirements for scholarships to come to the auditions to compete for scholarships.

Program applications for theatre and dance may be obtained from the department or downloaded from its Web site. Applicants must first be admitted to Ball State before they will be considered for admission to the Department of Theatre and Dance. However, students are encouraged to submit the university and program applications at the same time to expedite the process. Applicants who are not admitted to the acting, musical theatre, or dance options may still enroll at Ball State, declare the theatrical studies option, and audition again after completing a semester on campus.

In the program application, students will be asked to submit/complete the following:

- Performance audition. Students auditioning for the acting, musical theatre, or dance options will automatically be considered for scholarships. A separate audition is not required.
- Scholarship interview, if applying for a non-performance option.
- One-page resume and recent 8 x 10 inch photograph of yourself (full body, if applying for dance).
- · List of formal dance training you've had, including the studios, types, hours per week, and years of study.
- If applying for musical theatre or dance, information on your music reading ability, voice and/or piano study, and any other instruments you play. Two music selections of 16 bars marked with start and stop will be needed for the musical theatre audition.
- If applying for dance, written statements about why you want to major in dance at Ball State and why you are deserving of a dance scholarship.
- Signed letter of recommendation from someone who knows your work, such as a teacher or director.

ART

Students interested in the Department of Art's four-year professional degree options in the disciplines of ceramics, drawing, electronic art and animation, metals/jewelry design, painting, photography, printmaking, sculpture, and visual communication (graphic design) or the teaching major in visual arts must apply and submit a portfolio of work for admission to the department's common first-year program of study.

Admission to the first-year program is a two-stage process that requires the submission of both the general university application and the art program application. On the university application, it is important that you declare a major in art. Students who indicate art as their intended major on the university application will automatically receive the Department of Art's application materials, including a scholarship application, by mail to their home address. The program and scholarship application also may be obtained from the department upon request.

Applicants must first be admitted to Ball State before they will be considered for admission to the Department of Art. Students are encouraged to submit

the university and program applications early to expedite the process. Applicants who are not admitted to the art programs may still enroll at Ball State, declare a pre-art major, and reapply after completing the first-year foundation courses.

In the program application, students will be asked to submit/complete the following:

- Portfolio of work. In preparing a portfolio, you should select artwork that represents your current creative and technical abilities. You will need to submit 5–10 works for regular admission, or 10–15 works if applying for scholarships.
- Three drawings from direct observation, to be included as part of your portfolio.
- If applying for scholarships, your response to an essay question, a resume, a recommendation form filled out by a teacher or counselor, and slides (or PowerPoint) of artwork.
- Transcripts. The transcripts you submit to the Office of Admissions will be reviewed as part of the art application.

INTERIOR DESIGN MUSIC

INTERIOR DESIGN

To major in interior design, students must apply for admission to the program through the Department of Family and Consumer Sciences. The program application may be obtained from the department or downloaded from its Web site. Applicants must first be admitted to Ball State before they will be considered for admission to the interior design program. However, students are encouraged to submit the university and program applications at the same time to expedite the process.

The interior design program admits students who have excelled academically and who demonstrate strong design potential. Admission is highly competitive, and you are strongly encouraged to apply early. On the general university application, you should indicate interior design as your intended major.

In the program application, students will be asked to submit the following:

- Portfolio of related work, no more than five pages in an 8.5 x 11 inch format. You are encouraged to bring a full-size portfolio to your personal interview.
- Typed essay of 500 words or less that explains your interest in and career plans for interior design.
- List of your school and work activities related to interior design, including classes you have taken such as CAD, drawing, or interior design.
- Two signed letters of recommendation, one from a high school teacher (or university professor, if transferring), and one from a teacher, high school guidance counselor, or employer.

MUSIC

Students wanting to pursue a major or minor in music—music education, performance, music technology, or composition—must apply and audition for admission to the School of Music as well as scholarship consideration. In addition to auditioning, music technology applicants will be interviewed.

The program application may be obtained from the School of Music or downloaded from its Web site. Applicants must first be admitted to Ball State before they will be considered for admission to the School of Music. However, students are encouraged to submit the university and program applications at the same time to expedite the process.

In the program application, students will be asked to submit/complete the following:

- Performance audition on a primary instrument with faculty from that area, demonstrating your proficiency in keyboard, symphonic instruments (strings, woodwinds, brass, percussion), guitar, voice, or harp.
- Music theory exam that includes pitch identification, scales (major, harmonic minor, melodic minor, natural minor), key signatures (major and their relative minor), intervals (identify and notate), rests, note-values, and simple melodic notation.
- · Piano placement and ear-training exams, given on the audition day.
- List of your principal instrument/voice, high school music instructor, private instructor, years of musical study, materials studied, and ensemble experience.
- If applying for music education, a list of your teaching experiences and leadership opportunities with youth and children, and a brief paragraph about your reasons for wanting to pursue a career in music education and your long-term goals.
- If applying for music technology, a list of the most advanced science and math classes you have taken or will take, your previous music technology experience, and the reasons you want to study music technology at Ball State.
- · At least one signed letter of recommendation from someone in the music profession (band director, choral director, or private teacher).
