Policy Regarding Minimum Levels of Master's and Doctoral Stipends

Effective date (fall semester 2010)

Graduate assistantships at Ball State University are granted to those students whose applications are strong and/or unique in comparison with other applicants. Along with a waiver of tuition, these students receive a stipend to support them during their studies at Ball State University; this is very common among other universities. The student on a full-time assistantship is committed to 20 hrs/week of assisting the granting department and must be enrolled for at least 6 graduate credit hours of study each semester. The 2007-2009 Graduate Catalog listed the minimum stipends as \$2,000 for master's students and \$3,000 for doctoral students. Using a current Federal Minimum Wage calculation, the stipend would be \$4,640; we have removed the outdated minima from the newest Graduate Catalog. After reviewing all of the master's and doctoral stipends on campus, a formula was designed to allow the minimum stipends to increase as the Federal Minimum Wage increases. The normal increases in the assistantship pool should outgrow the increases in minimum wage; if not, then adjustments will be made.

Starting July 1, 2010, a new formula to set the minimum level of academic year master's assistantship stipends at 40% above the Federal Minimum Wage and minimum doctoral assistantship stipends at 60% above the minimum master's assistantship stipend level will be in effect. These minima will be campus-wide (on all account designations) and automatically change with the Federal Minimum Wage level. The new minima are consistent with area and peer universities and are within a range that is achievable by current funding levels in departments and units.

The new formula for calculating master's stipends will be:

Minimum wage x 20hrs/week x 16 weeks/semester x 2 semesters x 1.40 = AY master's stipend

The new formula for calculating doctoral stipends will be:

AY master's stipend x 1.60 = AY doctoral stipend

Starting July 1, 2010, the new minima will be as follows:

Master's Academic Year = \$6,496 (1/2 assistantship = \$3,248)

Doctoral Academic Year = \$10,394 (1/2 assistantship = \$5,197)

Below is a projection of minimum master's and doctoral stipends as minimum wage changes (by projected \$0.50 increments).
